Respectfully Sheweth:

1. That as in terms of this Hon’ble Court’s Order dated 06.06.2018, reply on behalf of Mian Muhammad Nawaz Sharif, to the specific allegations made against him as has been indicated in the decision of this Hon’ble Court in Air Marshal Asghar Khan’s case (PLD 2013 SC 1), is as under:
 - 1) Mian Muhammad Nawaz Sharif had never received an amount of Rs.3.5 million from Lt. Gen. Retd Asad Durrani Ex. DG ISI and/or under his instructions from his representative as donation to spend on election campaign in general elections of 1990.

- 2) Similarly no amount in the sum of Rs. 3.5M and 2.5M was given to Mian Muhammad Nawaz Sharif by Younus Habib and/or under his instructions.
- 3) In this regard Mian Muhammad Nawaz Sharif has already got his statement recorded on 14.10.2015 before the Enquiry Committee (the Committee) constituted pursuant to registration of Enquiry No.47/2013 in Special Investigation Unit (SIU) FIA HQ, Islamabad under FIA Investigation/Enquiry Rules, 2002 in compliance with the Hon'ble Court's directions contained, *inter alia*, in para 102 (14) of the above-cited judgment.
